Mackamide C is produced using the 1:1 reaction from a pure grade of coconut oil and contains a small amount of residual glycerin. **Mackamide C** is high active and readily biodegradable. It is liquid at room temperature and below, simplifying handling during manufacturing. **Mackamide C** has a low free diethanolamine content that meets the requirements of the European directive relating to residual diethanolamine in alkanolamides used in personal care products.

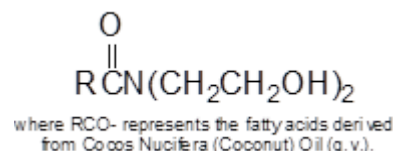

Mackamide C should be stored in sealed containers below 30°C in a dry place out of direct sunlight. If material becomes hazy after exposure to cold gently heat to 35°C and mix before use. Handle between 15°C – 90°C.
