## How to work with dermosoft® MCA Variante

#### Manufacturing procedure

#### In emulsions

- Recommended procedure: mix with the aqueous phase before emulsification
- Also possible to add to the oil phase
- Suitable for cold or hot process, up to 80°C

*Note:* **dermo**soft<sup>®</sup> MCA Variante may have an influence on emulsion viscosity & stability. Check carefully.

#### Surfactant based products

- The antimicrobial performance of **dermo**soft<sup>®</sup> MCA Variante is depending on the surfactant matrix. The inclusion into surfactant micelles might reduce the efficacy of **dermo**soft<sup>®</sup> MCA Variante
- A combination with fungicidal antimicrobial is advisable

#### **Aqueous products**

• dermosoft® MCA Variante can be introduced with the help of a solubilizer

#### **Formulation advice**

Consider pH during manufacturing procedure	Do not fall below pH 4.0 or exceed pH 7.0
Boost antimicrobial efficacy against mould	Combine with organic acid, e.g. <b>dermo</b> soft <sup>®</sup> 688 or Ethanol





Foundation O/W Emulsion based on dermofeel® GSC with 1% dermosoft® MCA Variante (pH 5.4)






